1. Venue



The RIPESS Europe General Assembly will be hosted at the E-graine Maison de la Nature et de l'Environnement Bordeaux Aquitaine offices!

E-graine is a grassroots educational movement that fosters civic engagement and helps build more welcoming, supportive, and responsible communities. Through creative learning projects, it empowers people to understand social issues and act as agents of change.

2. How to get to E-graine Maison de la Nature et de l'Environnement

Address

2 Quai de Brazza Bord de Garonne, 33100 Bordeaux, France

From Bordeaux Airport

There are several choices of route to reach <u>E-graine</u> from Bordeaux Airport. We just mention 2 different routes:

- 1. From Bordeaux Airport take Tram A at Aeroport station and exit at Thiers-Benauge Station (25 stops, approx. 48 min). From Thiers-Benauge Station there is a 16-minute walk to E-graine. (Total duration 1 hr. 6 min)
- 2. From Bordeaux Airport take Tram A at Aeroport station and exit at Jardin Botanique Station (24 stops, approx. 47 min). From Jardin Botanique take Bus 61 and exit at Bouthier station (4 stops, approx. 4 min) and then 3-minute walk to E-graine. (Total duration 1 hr. 7 min)




From Bordeaux Train Station (Gare SNCF de Bordeaux Saint-Jean)

The fastest route according to the maps takes 38 minutes.


From Gare SNCF de Bordeaux Saint-Jean walk for 6 min (350 m) up to the Tauzia Station, take Tram line C (Gare de Blanquefort) up to Porte de Bourgogne station (5 min, 3 stops). Then take Tram Line A up to Thiers-Benauge station (5 min, 3 stops). From Thiers-Benauge Station there is a 16-minute walk to E-graine.





From the Hotel de l'Opera to E-graine

Hotel De l'Opéra, 35 Rue Esprit des Lois, 33000 Bordeaux, France



From Hotel De l'Opera to E-graine the distance is 2,5 km and it is 31 minutes walking plus the ferry to cross the river.

There is another route that takes approx. 18 minutes. From the Hotel walk for 6 min up to Quinconces Jean-Jaurès, take the Ferry 952 Les Hangars for 8 minutes up to Bastide Darwin. From there walk for 4 minutes up to the venue.

4. Global SSE Forum 2025

The Global SSE Forum 2025 is a key event on the road to achieving sustainable development goals. With 5 years to go before the 2030 Agenda, it will bring together civil society and local and regional authorities to get things moving, challenge decision-makers and speed up the just transition. This meeting is also part of a dense and decisive global sequence, just a few days away from the World Social Forum in Doha (4-6 November 2025), which will bring together heads of state and government to accelerate the implementation of a new global social contract based on the reduction of poverty.

In this context, <u>Bordeaux GSEF 2025</u> will be a powerful reminder of the key role played by local governments and civil society in building sustainable, inclusive development rooted in the territories. This is a strategic moment to share concrete solutions, strengthen cooperation and make the voice of local players heard on a global scale. This is more crucial given the many threats facing the world today: wars, authoritarian regimes, economic disorder, hardening social relations, ecological disasters, disinformation, etc. The SSE is witnessing a new narrative that it is up to us all to write.

5. Charter of Principles and SSE Strategy documentation

After one year of collective work within the Foundations Working Circle — and through several workshops held during our previous General Assemblies — we have co-created an updated *Charter of Principles*. During our General Assembly, we'll come together to validate this renewed Charter, a true collective achievement that aims to inspire and guide RIPESS's future actions, alliances, and shared strategy.

After validating the <u>Charter of Principles</u>, we will present a proposed SSE Strategy aimed at reorienting our collective vision and action in response to the challenges and opportunities of this new era. Together, we'll explore the main directions that the SSE movement should take to preserve its transformative character and to effectively respond to current social, economic, and political contexts.

The session will include a short presentation of the strategy proposal, followed by collective discussions to refine and confirm the key orientations. We will also work together to identify concrete actions aligned with the main strategic axes — ensuring that our shared vision translates into meaningful initiatives and stronger collaboration within the RIPESS network.

7. CoCo Candidates

As our General Assembly meeting approaches, we would like to prepare in time in order to have as many members as possible engaged in the Circles (working groups and decision-making spaces) and nominations for the Coordination committee, which will also be done through the Circles.

To see the document that explains how the new sociocratic structure works press here

- 1. Choose an area of interest in which you think you could engage for 1-2 hours a month (or more if you can). That includes a meeting and some time to read / elaborate documents or proposals / activities in any of the following Circles:
 - ECOSYSTEMS (promoting SSE territorial / inter-sectoral circuits; inter-cooperation and thematic SSE projects eg. Youth, Agroecology, Cooperative Housing, Renewable Energy Communities, Solidarity Tourism, etc.)
 - RECOGNITION (SSE campaigns, advocacy, policy and positioning, visibility)
 - MOUVEMENT BUILDING (alliances, participation in social movements' events, spaces and processes, such as WSF, ECSA, NYELENI, etc.)
 - SSE FOUNDATIONS (knowledge commons and action-research, strategy, charter of principles)

and/or in any of the functional ones:

- SHARED GOVERNANCE (institutional and legal issues, improving the governance structure and facilitation, elaborating the internal regulations and organisational policy)
- FINANCE, PEOPLE (HR) AND FUNDRAISING (monitoring and supporting the budget and financial planning and the team's wellbeing)
- COMMUNICATION (internal and external communication strategy and visibility)
- CARE AND MEMBERSHIP SUPPORT (making sure the processes and network spaces are safe and care-full, taking care of the members especially new and perspective ones)

Consider that the CoCo meets once a month online, for 2 hours. As Lead you would be expected to convene the Circle meetings and facilitate, with the help (if required) of one of the Team members. The frequency and duration of Circle meetings will be up to its participants - but you might consider



another hour or two a month. So, the minimum engagement as a Lead for the CoCo would be half day a month.

If we are able to distribute among us and involve all of us in the network's activity and decentralised decision making - this will be a big step forward!
